COVID-19: PARENT/GUARDIAN RESPONSIBILITIES AND ACKNOWLEDGMENT

Please read and initial each statement below. All three pages are required in order to register for any Palm Arts Dance class.

I understand that I, as a parent, will NOT be permitted to enter the facility beyond the designated drop-off and pick-up area. I understand that this procedural change is for the safety of all persons present in the facility and to reduce everyone's risk of exposure.

INIT: _____

I understand that to enter the studio premises, my child must be free from COVID-19 symptoms. If any of the symptoms listed below appear, my child will be separated from the rest of the people in the studio and my child MUST be picked up from the studio immediately. Palm staff will be taking temperature readings each day before class.

Symptoms include, but are not limited to:

- Fever of 100 degrees Fahrenheit or higher
- Dry Cough
- Shortness of Breath
- Loss of Taste or Smell
- Sore Throat
- Muscle Pain/Body Aches
- Congestion/Runny Nose
- Nausea/Vomiting
- Diarrhea

While many of these symptoms might be non-COVID-19 related, Palm Arts is practicing an abundance of caution and assuming they are COVID-19 related during this Public Health Emergency. If my child has any of these symptoms, they must stay home. My child will need to be symptom free before returning to the facility.

INIT: _____

I understand that all students will be required to use hand sanitizer upon entering the studio according to CDC recommended hand washing procedures.

INIT: _____

I understand that all students will be required to wear masks in our common areas and the bathrooms, and when feasible in our studios. Dancers should have their masks with them at all times, both in the studios and outside of the studios.

INIT: _____

I will immediately notify Palm Arts Dance management if I, my child, an immediate family member, or anyone with whom my child has come into contact tests positive, or is presumed positive, for COVID-19.

INIT: _____

I will immediately notify Palm Arts Dance management if my child's school classroom, applying to both the public school and Mountain School, receives a notice of quarantine due to a confirmed COVID-19 case.

INIT: _____

I understand that students entering our studio will be in contact with children, families and employees who are also at risk of community exposure. I understand that Palm Arts cannot guarantee that my child will not become infected with COVID-19. I understand that no list of restrictions, guidelines or practices will remove 100% of the risk of exposure to COVID-19 as the virus can be transmitted by persons who are asymptomatic and before some people show signs of infection. I understand that I and my child play a crucial role in keeping everyone in the facility safe and reducing the risk of exposure by following the practices outlined herein.

INIT: _____

I understand that should there be a spike in COVID-19 cases and we are forced into a Shelter in Place (SIP) situation again, all classes will continue virtually. Tuition will remain the same for virtual classes. Should the SIP restrictions last more than six weeks, Palm Arts reserves the right to end the session of dance entirely and will refund any tuition pro rata.

I acknowledge that my child's failure to act in accordance with the provisions listed herein, or with any other policy or procedure outlined by Palm Arts, will result in disciplinary action up to and including termination of registration at Palm Arts Dance with no refund for fees paid.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRIS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is highly contagious and is believed to spread mainly from person-to-person contact.

Palm Arts, Inc. has established preventative measures to reduce the spread of COVID-19 in our studios, performance and ancillary spaces, however, Palm Arts cannot guarantee that dance students or their families will not become infected with COVID-19. By participating in any athletic activity, risk of exposure to COVID-19 could be increased.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) or I may be exposed to or infected by COVID-19 by attending Palm Arts Dance programs and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Palm Arts Dance may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Palm Arts employees, volunteers, program participants and their families.

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Palm Arts, Inc., its employees, agents and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omission or negligence of Palm Arts, Inc, its employees, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Palm Arts Dance programs.
